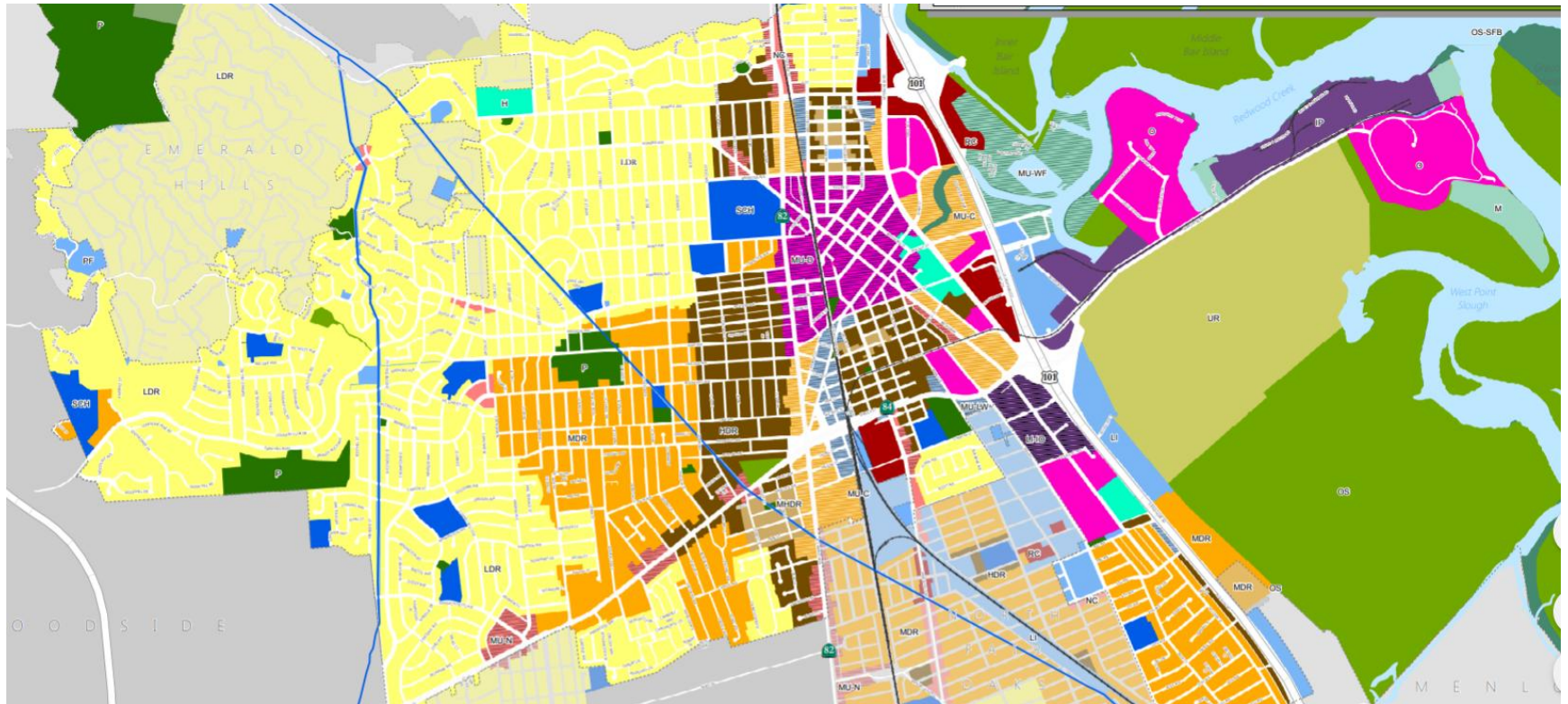
### Trump EPA Clean Water Act Change
