Ms. Arechiga will email Commissioner Merrilees the dates when the cameras would be deployed.

Commissioner Cooney suggested reaching out to local camera vendors for potential discounts or donations of cameras.

Community Programs Specialist Carla Schoof, in response to Commissioner Okelo, reported on Intern Gabrielle Navarro's community outreach for the Parks Shuttle Program, and the use of the shuttle by the Sienna Youth Center.
